

## MINUTES FROM August 3, 2010

## Reports:

**Secretary:** Minutes from July 6, 2010 were read and accepted.

A total of \$1,009.00 was received, with \$883.00 from group contributions, \$26.00 from the RCI collection and \$100.00 in meeting list sales. Total expenses paid during the month were \$786.20, leaving a Closing Working Balance of \$1,646.95. Report was accepted.

Share A Day: Charlie I. reported that the Share a Day Committee had received \$1,000 in seed money from RCI. The Committee had already received \$382.25 from pre-event ticket sales (and has a network of 38 AAs doing advance ticket sales). The Committee has expended \$300 to obtain the liability insurance coverage required by Rockland Community College and \$16.17 for supplies, with the balance on hand to pay other expenses. Event T-Shirts are being made which will be sold during the event. Musical entertainment will be presented instead of the play. Flyers for Share A Day and for upcoming Committee meetings were passed out. It was suggested that all group representatives make announcements about Share A Day at all of their meetings to encourage AAs to participate. Al-Anon will also be there and conducting its own meetings. Planning meetings are scheduled for August 5th, 12th and 19th at 7:00 pm at the Nanuet Diner, all are welcome to attend. Share A Day ticket prices are \$15.00 in advance and \$20.00 on the day of the event in an effort to make Share A Day self-supporting and put it in a position where it can repay the RCI seed money. The AA speaker for the Big AA Meeting will be Lorna K, from Manhattan who has 35+years of sobriety. Children under 12 are free and child care will be provided. The event has been posted on the RCI web site.
