

ROCKLAND COUNTY INTERGROUP Minutes from January 8, 2013

REPORTS

Secretary Report: (Anne) Read and accepted.

Share-A-Day: (Shifra) First planning meeting for 2013 Share-A-Day is scheduled for Saturday, February 23, 2013 @ 9:30 a.m. at the Nanuet Diner.

Treasurer: (Jamie) Opening working balance for December was \$6,250.51. Group contributions were \$445.00, plus \$130.00 meeting list sales. Total expenses during the month were \$1,533.94, leaving a closing working balance of \$5,291.57. YTD expenses of \$11,057.66 were covered by Group contributions and meeting list sales, which totaled \$11,462.42, leaving the prudent reserve intact. Final Share-A-Day numbers: total receipts were \$1,153.35; expenses were \$1,372.42 (rent \$1000, insurance \$300, breakfast \$72.42), leaving a \$219.07 shortfall. Intergroup's \$200 contribution leaves a shortfall of \$19.07. Share-A-Day reserve (\$1100) is intact.
