**Share-A-Day:** (Jamie) First planning meeting for 2013 Share-A-Day is scheduled for Saturday, February 23, 2013 @ 9:30 a.m. at the Nanuet Diner.

**Treasurer:** (Jamie) Opening working balance for January was \$5,291.57. Group contributions were \$1,715.31, plus \$50.00 meeting list sales. Total expenses during the month were \$723.23, leaving a closing working balance of \$6,333.65.

Women's Corrections: Caitlin has reviewed the commitment's requirements, and will organize the materials Elsa passed on to her. Although meeting chair positions are currently filled, both meetings can use volunteers willing to take on a commitment (as chair or co-chair) so that current chairs can rotate out gracefully. Meetings are held Monday and Wednesday nights @7:30 p.m. at the Rockland County Correctional Center in New City; requires two years sobriety, no outstanding warrants, and five years since release if once an inmate there. Length of commitment is currently one year. Anyone interested should speak with their Intergroup rep. or contact Caitlin through the Intergroup website's Corrections link.

Men's Corrections: Intergroup needs a new Men's Corrections Chair.
