Secretary Report: (Anne) Read and accepted.

Treasurer: (Jamie) Opening working balance for July was \$1,402.70. Group contributions were \$552.84 plus \$30.00 meeting list sales. Total expenses during the month were \$509.40, leaving a closing working balance of \$1,476.14 (plus \$5,500 prudent reserve = \$6,976.14 total funds).

SENY Liaison: (Mike) Rockland County General Services is moving ahead to visit groups who do not have GSRs to encourage them to participate, and voted to spend up to \$100 to provide literature to home groups about General Services. The CPC Committee (Cooperation with Professional Community) needs a committee chairperson.

Women's Corrections: (Caitlin) Meetings are being covered; she is still working on writing up guidelines for speakers.

Men's Corrections: Edward D. is the new Men's Corrections Chair. Request approved for \$50 for literature. He is working to clarify the role of Meeting Chairs and procedures for finding speakers.
