VI. DCMC Report-

Attended Putnam County S/B, Suffolk County Big Meeting

Spoke briefly about the status of the Alcothon- explained that this year the Haverstraw Center wanted a higher Insurance Rider than in the past and due to the increased cost the body would need to decide if it was going to be strictly Virtual or a Hybrid approach as had been planned, Explained that the 13 slots were filled—opened the floor to questions that were fielded by DCMC & Event Chair- there was a lot of confusion about the actual format, Would there be Covid Guidelines, How would groups contribute to the 7th Tradition since we don't have a virtual collection system yet, Could groups run their meeting from a fully remote setting and the answer was yes—What was the final format: A Chair and 2 speakers, as in the past—Security as in the past to be done by volunteers from the groups

Due to the large increase in the Insurance premium it was Moved and Voted that we proceed with The Hybrid Style-(live and Remote) and buy the more expensive event Insurance in accordance

Moved on to discussion of our responsibilities for the SENY Rotating "Joy Of Service" Workshop—it was decided that we would have to pass on it until later in our schedule, perhaps The May or June Slot

Opened discussion of the Spiritual Breakfast(S/B) jointly with the chair of that Event The final Ticket proofs will be back from the printer, shortly—The flyer has been completed—information to be sent to the SENY Agenda Chair for posting on their Website—Questioned raised as to if it could also be turned into a Virtual Hyperlink Poster-Still to be discussed—discussion moved onto the Venue requirements for the possibility of less people and Tables-which they haven't answered back yet—The chair has set-up the tickets to help with the distribution and tracking—ticket will go sale in January, if we are still meeting Virtually there was some discussion as to how the tickets would be distributed to the GSR's for sales—DCMC has yet to finalize a SENY Speaker but the Committee Chair and Co-Chair have already booked the main Speaker—S/B is in. Good Shape

Asked for an Ad Hoc By-Laws Committee report—Was informed that the Committee had recently received a Historic Trove of Information, that needed to be incorporated but it was felt that it could all be incorporated and the working copy sent out to the committee before the end of 2021. If the committee can make the necessary corrections and emendations, the By-Laws will be ready for discussion and Passage at the January District Meeting

Asked about a Place to Call Home—The Secretary mentioned the possibility of a Virtual Address and brief discussion of the legal merits were discussed—Treasure to explore

DCMC brought up and advised all present about the recent COVID Guideline piece that the Area had put out which is very similar to the CDC Guidelines: Masks require for all indoor meetings, social distancing, etc. and recommended that all the Groups follow these guidelines

Introduced the SENY CONVENTION PUBLICITY who spoke briefly about the event details and explained that all the pertinent details would be on a landing page on the SENY Website—DCMC told the body that his new position for the Convention was Volunteer Chair—explained that RCGSC would have to have a slot at the Convention Alcothon and there is a possibility that at some of the bigger events would be Hybrid but that SENY is exploring the costs and the technical requirements.

VIII. Group Reports-

TMG- There are two Ninety Day celebrants for the month of December, 14 anniversary celebrants in all including one person celebrating 36 years of sobriety. We had 11 Celebrants in the month of November ranging from 90 days to 35 years. We have 3 Ninety Day celebrants this month
