- XI. **New Business-** The Treasurer reports that Insurance policies and Companies are still being reviewed but there is a likely candidate that will be presented to the E-Board for final approval, before all pending contracts become binding. It will cover our regular meetings as well as have the ability to add riders for special events. Additionally, the Treasurer reported that 7<sup>th</sup> Tradition Contributions are up slightly and that the budget is being look at for the half year review point of income vs. expenses.
